3. Briefly describe your project (who did what, when and where did project activities take place?) in 100 words or less. Blackfoot Rotarians expanded the local disc golf course from 9 holes to 18 holes and installed 9 launch pads which required a three phase project: 1) mark, locate, and excavate each launch area; 2) purchase and install pit run gravel and level and compact in each of 9 launch pads; 3) purchase and install asphalt and compact and level on each of 9 launch pads; purchase a banner for disc golf tournaments sponsored by Rotary Club annually as part of a Marathon Race which ends near the disc golf course and purchase of permanent signage to memorial Rotary’s contribution and work to expand the disc golf course. Sixteen Rotarians, seven friends, two people from Blackfoot Disc Golf Association, three city employees, and contributions and reductions in price from four local businesses all contributed to the project.
4. In one brief sentence: who were the beneficiaries of the grant activities and how many of them were there? All those who use the city park and the disc golf course; the number is in the thousands of users per year.
5. How many Rotarians participated in the project? 16 Briefly tell what did. Planned the project, did the paperwork for the grant, operated shovels, rakes, leveling equipment, sod removal equipment, measured and laid out the nine launch pad areas, dug out the sod, installed and compacted the pit run gravel, installed and compacted the asphalt, will display the banner at disc golf events, and helped plan and purchase the permanent signage documenting Blackfoot Rotary Club’s work to expand and install the 9 holes and launch pads on the disc golf course.

City of Blackfoot approved the project, city of Blackfoot allowed use of a pickup truck and a trailer, city allowed Parks Superintendent and employees to help for a few hours on phase 2 of the project (phase 1 and 3 were done on Saturdays when city employees not working).
