Project Description:	

1. Briefly describe the project. What was done and where did the project activities take place? Explain how the beneficiaries and other community members were involved?

In the buffer zone of the Montecillos Biological Reserve in Honduras, the Mesoamerican Pine Beetle has wiped out half of existing Honduran pine trees which protected the coffee plants from the tropical sun. In addition, a coffee fungus has reduced production by up to 60% in some areas. This has resulted in an economic crisis for the communities surrounding Montecillos. As income dries up, families struggle to meet their most basic needs and end up exploiting the natural resources in the Reserve to make a living. Without the support of projects like this one, local communities begin to eat away at the next generation's resources, resulting in environmental degradation, and increased migration away from rural areas to urban centers and other countries.

Through this project with partners Trees, Water & People (TWP) and the Center for Education in Sustainable Agriculture (CEASO) in Honduras, Rotary built resilience into the recovery by providing to each community in the area:

- 1. 25 Healthier cookstoves, built to local cultural preferences, that reduce fuel-wood consumption by 50% and improve the health of the community. All cookstoves were built with local labor and materials.
- 25 Cisterns built by the community using locally-available materials to catch local rainfall for household tasks, leaving scarce local spring water for drinking. All cisterns were manufactured in-place by trained and empowered community members.
- 3. Two diversified tree nurseries to replace the devastated pine canopy with varieties of trees that can produce alternative income over time (protect coffee trees and provide

fruit for income). These nurseries are cultivated and managed by the communities, including kids from local schools.

Since this project is in a very remote area of Honduras, training and monitoring of the implementation of the above work was completed by local professionals from CEASO and TWP.

This project assisted two communities in their recovery from the environmental disaster.

This project was started by Rotary Peace Scholar Lucas Wolf (class of 2006 - 2008, sponsored by District 5440) while he was the International Director of Trees Water People (TWP), an NGO that works with rural communities throughout Central America and on U.S. Tribal Lands.

Lucas unexpectedly passed away at age 36 while attending an environmental conference in Havana, Cuba. Until his death, Lucas remained very active in the Rotary Peace Fellow alumni organization, traveling often to speak and/or participate in Rotary-sponsored peace conferences.

The Rotary Club of Fort Collins Breakfast and TWP worked to develop a project in Lucas' memory which related to his passion. With this project, TWP and Rotary are carrying on his legacy, and kicking off a 5-year effort to plant 1,000,000 trees in his name. This project was his last passion project and is a very fitting memorial for him.

One Rotarian coordinated the project donations, monitored the project's status, and updated the project on www.matchinggrants.org.

The second Rotarian traveled to the project locations in Honduras in November, 2019, interacted with the affected communities, and verified the effectiveness of the installations.

5. Who are the beneficiaries and what is the expected long-term community impact of this project?

The beneficiaries are members of two communities located near the Montecillos Biological Reserve in Honduras.

In the long term, this project will:

- 1. Help the communities diversify their economies from a single source of income (coffee) to additional sources, including crops from mature trees grown in the provided tree nurseries.
- 2. Enable the communities to collect and provide water for their communities from the cisterns provided by this project rather than harming the Biological Reserve environment to gather water daily from water sources in the Reserve.
- 3. Improve the health of the community, especially the women in the community by providing healthier cookstoves the conform to local cultural practices.
- 6. If a cooperating organization was involved, what was their role?

There were two partner organizations: Trees, Water & People (TWP), a Fort Collins, CO, based NGO which managed the project and the Center for Education in Sustainable Agriculture (CEASO, a Honduran NGO which coordinated the logistics of supply and construction.
