**Project Title** Rotary Academic Scholarships

  - The Rotary Club of Oak Lawn awards academic scholarships to deserving graduating high school students who have demonstrated high academic achievement while also showing a strong commitment to service above self. Scholarship amounts are \$1,500 per recipient, with four students selected to receive the award. When possible, payments are made directly to the college or university where the student is attending.
- 2. How many Rotarians participated in the project?
  - All 16 members of the club were involved in promoting the scholarship program, reviewing the applications, selecting the recipients, and recognizing those students and their parents at an annual luncheon.
- 3. What did they do? Please give at least 2 examples.

  - Four students from the Village of Oak Lawn received the scholarship awards. These students, along with their parents, benefitted from this project.

    Scholarship Program. We hope and expect that these values will be reinforced for these student recipients into the
    long-term future.

  - Letters and emails were shared with the Principals and Counselors at high schools in the Oak Lawn area promoting the program. Social media was also used to promote the scholarship program, as well as to recognize our scholarship recipients.
