  The Dolly Parton Imagination Library is a program that provides one book/month (free) to children aged 0 5 yrs. Each \$25 of funding provides one year of books to a child. In partnership with the Routt County United Way, our club is helping to facilitate the registration of all eligible children in Routt County through enrolling children at a wide array of locations throughout our county. We also support the afterschool reading program in two elementary schools.
