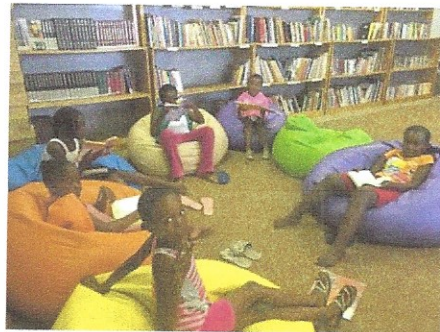
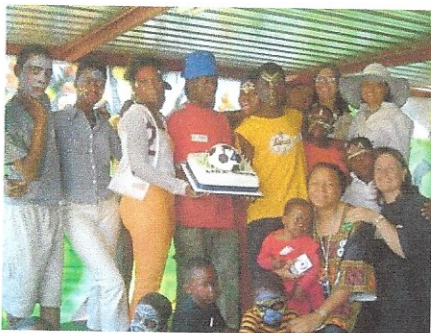

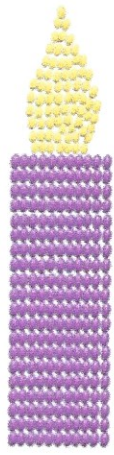

The Birthday Xperience is a capacity building programme where local community children learn organizational skills by project managing not only their own Birthday experience but small activities on the event Calendar aligned to the Sustainable Development Goals for which they can earn SDG badges

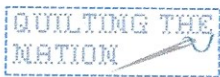
- The youth who run the Birthday Xperience programmes will be learning how to organize small low key successful events and how to work with suppliers in the event value chain – supporting the social circular economy

The children would participate in a variety of activities over the year, but basically meeting once a week - like the Jane Goodall's roots & shoots club, The Local Story Exchange, the Heroes for Change, Life's a Ball, Mini-Chess and more.... igniting creativity and learning new skills through the planning, preparing and producing of small activities aligned to the Sustainable Development Goals The children would enjoy

- a lunch snack – like soup and sandwich at the weekly programme – supporting the Food & Beverage Cooperatives.
- a "city safari" jacket onto which they could attach the SDG badges that they earn - supporting the Sewing Cooperatives and the Print Marketing Cooperative.
- Working with the Performing, Creative & Visual Arts Cooperatives who would inspire creativity in the planning, preparing and producing of mini-parades aligned to the Sustainable Development Goals
- Spending time in the proposed Tech Centre managed by the IT Coop and participating in coding - simple robotics and other activities
- Participating in the FUNdamental FUNfair at the planned Local Community Market Days for local communities. Introducing entrepreneurship alongside social and environmental responsibility

The elders would be invited to participate in the Mbawula Dialogues and Quilting the Nation and Stories behind the Recipes project which would result in a series of Quilts telling the story of the local community as well as a series of recipe books.

The parents would be invited to participate in the planning, preparing and producing of the Local Community and Market Day at which their children would have their FUNdamental FUNfair activities. As well, creating the opportunity to engage with families through the social workers, using **the Poverty Stoplight movement towards poverty eradication in South Africa.** Poverty Stoplight is an approach that helps people progress out of poverty by empowering them to understand and map their own choices. It encourages households to participate and own their journeys out of poverty, and provides a clear line of sight of how to get there; at the same time allowing organisations delivering support to measure progress against their programme objectives

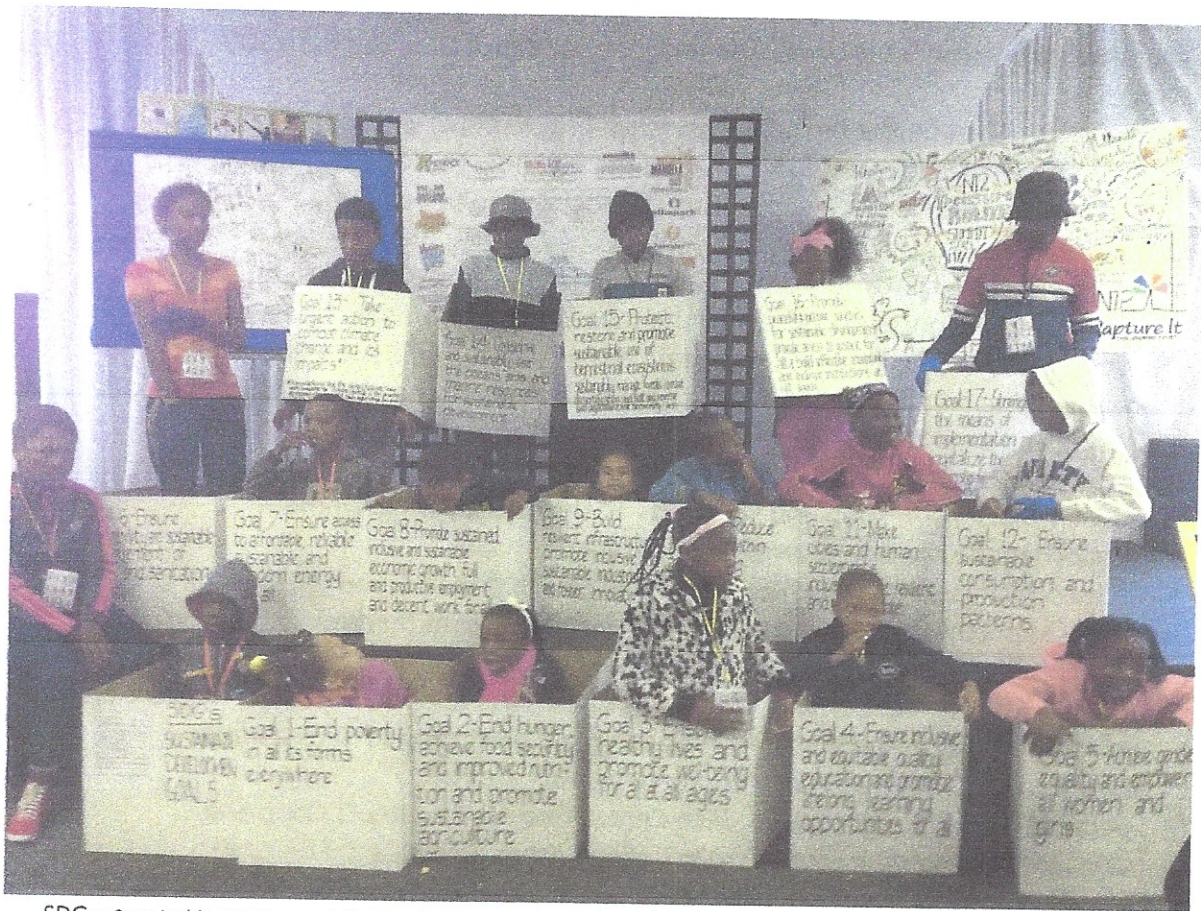

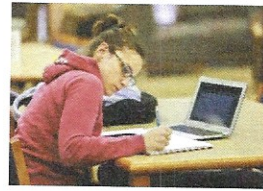
TCC Foundation *Eliminating Barriers Fund*

Many middle-skill level jobs await a community college graduate with the correct training/skill level. Community colleges enroll more than 40% of the undergraduate population, and graduate thousands each year who enter the workforce. But success does not come to all who enroll - less than 40% of community college students obtain a degree within six years, and students from low income families are even more likely to drop out. Given that community college students tend to be financially independent and older (typically about 26 years of age for TCC students), financial and family issues frequently arise and pose challenges to staying in school. These problems include balancing work and school, finding appropriate and affordable day care, and dealing with unexpected setbacks that occur during the school year. The impact of college completion is positively felt not only by the individual and his/her family, but by the greater community as well. In his book *Triumph of the City*, Harvard economist Edward Glaeser cites that as the share of the population with college degrees increases 10 percent, per-capita gross metropolitan product rises 22 percent (Glaeser 2017). **The entire region benefits from an increase among college students who complete.**

To help mitigate the drop-out rate, Tarrant County College Foundation, in collaboration with the Vice Presidents of Student Development on each TCC campus, has created the *Eliminating Barriers Fund* – established to help address financial needs students face that may cause them to ‘stop-out’ of their current TCC coursework or job skills training, or drop-out altogether. Any number of one-time ‘catastrophes’ -- burst water pipes, balding car tires that do not pass inspection, a medical need, a refrigerator or washing machine that ceases to function – can cause a significant financial strain on a community college student’s budget. The financial need may cause the student to take on more hours at work, or even a second part-time job to address the problem. And when a student runs out of hours in the day to get it all done, college coursework will be the first thing to go, impairing the opportunity to complete a degree or certification program.

Tarrant County College and TCC Foundation desire to assist students who find themselves facing *urgent, unforeseen* and *non-recurring* situations that threaten to derail them from their collegiate course.

Student application requests for financial support through the *Eliminating Barriers Fund* are reviewed, vetted and approved at the campus level. If a situation impedes a student’s ability/capacity to continue to attend classes, TCC wants to help keep the student in school by providing some financial assistance to address the problem. *Staying in school and completing designated degree/certification plans* are important keys to a student securing a wage-sustaining job that results in a satisfying career. Students who receive support from the *Eliminating Barriers Fund* will have a required follow-up appointment with a TCC professional to ascertain any potential ‘deeper’ problems facing the student, and work to help mitigate.

Entrepreneurial Studies Scholarship

This scholarship was created in 2015 with support and leadership by Tarrant County College Board of Trustees member, Conrad Heede, to benefit students pursuing a certificate and/or degree in entrepreneurial studies and to encourage an entrepreneurial spirit.

Criteria for eligibility:

- Must be currently enrolled at or entering Tarrant County College with the intent to pursue an associate degree or certificate of completion in entrepreneurial studies or business-related curriculum.
- Must have a minimum TCC GPA of 2.75. A high school equivalent or a passing GED score is acceptable if a first-time TCC student.
- Must enroll in a minimum of 6 credit hours, with at least one class in the business curriculum (BUSI, BUSG, BMGT, MRKG, ACCT, or ECON) for period of award.
- Must have an intention to own one's own business.
- Preference given to applicants who meet federal or state guidelines for financial need.
- Recipient will receive a spring scholarship if a minimum semester GPA of 2.75 is achieved and a minimum of 6 credit hours are completed in the fall.
- This scholarship is awarded for up to four consecutive semesters if a minimum semester GPA of 2.75 is achieved and a minimum of 6 credit hours (including business/entrepreneurial studies coursework) are completed each semester.

To apply complete the following:

- Online TCC Foundation Scholarship application accessible through www.tccd.edu/scholarships. Incomplete applications will not be considered.
- FAFSA/TASFA for current academic year, used to determine financial need. FAFSA online applications accessible through www.fafsa.gov. Paper TASFA applications available at Student Financial Aid Services offices. **Financial need process must be completed by May 1st.**
- First-time TCC students must provide an academic transcript or GED scores, if applicable. Students transferring to TCC from another institution or graduating from high school in the spring will need to submit a **current transcript by May 1st** and a **final transcript by July 8th** to the Admissions and Registrar's office.

Amount: \$500.00 per fall and spring semesters at half-time status or \$1,000.00 per fall and spring semesters at full-time status
