Project Title Outbound Youth Exchange

1. Briefly describe the project. What was done, when and where did project activities take place, and who were the beneficiaries? List any changes that might have occurred.

Our club was presented with our first opportunity to sponsor an outbound youth exchange student. The student Fletcher Fraher, was an applicant from Whitney Young High School in Chicago. After interacting with several members at District 6450's RYLA, it was approved that we would sponsor Fletcher for his exchange in the 2020-21 school year. Use of DDF and club matching paid for the \$800 sponsorship fee, with plans for the remaining \$132 to help support Fletcher in any needs, meeting attendance, or materials. Due to COVID-19, the status of the exchange is unclear, so we have not been able to apply the final \$132 yet.

All Chicago Lakeview members served as facilitators and counselors for District 6450 RYLA, interacting with and leading groups Fletcher was a part of. Amy Hopkins further served as the club's Youth Exchange Officer, and completed required trainings from Central States Youth Exchange and Rotary International. She coordinated with Fletcher and his family to complete club required paperwork, as well as communication about scheduling club visits and presentations.

Sue DeBolt is the outbound exchange coordinator and worked with Fletcher on applications, documents, and acceptance procedures. Cheri Vana is the inbound exchange coordinator and serves on the same committee helping to determine outbound candidates.

4. How many non-Rotarians benefitted from this project?

Three – Fletcher Fraher and his parents. Without RYE, he would not have had this opportunity and his parents are excited about the program and eager to learn more.

5. What are the expected long-term community impacts of the project?

Flecher is a leader in his school community, we expect that what he learns about other cultures, cooperation, peace building, and tolerance will only continue and enhance his potential to do good in the world through his leadership.
