The committee selected candidates to interview and interviewed the students one at a time. The committee selected six of the applicants to receive scholarships in varying amounts. The scholarship winners were announced and recognized at a general ceremony at the high school by the chairman and checks were sent to the various schools.

Four members of our club formed the Scholarship Committee.

The members reviewed the applications, discussed them and voted by email on whom to interview. The members interviewed the applicants and reached consensus on the winners. Our Scholarship Chair announced the awards at an awards and scholarship ceremony at the high school. Our treasurer prepared and mailed checks to the various schools.
