We were originally going to giveaway 20 masks to first responders in Chicago, instead we ultimately gave 200 masks away to children in lamestown, Accra, Ghana, along with hand sanitizers and snacks. The event took place at the Lighthouse in lamestown, Accra, Ghana, on October 27, 2020 at 3:30pm.

They also provided refreshments and served as translators. They were there from the set up to tear down and helped to disseminate the items. Masah SamForay, President of Rotary Club of Chicago Southeast was present in person to present the items, the masks and hand sanitizer, plus refreshments for the children), and was present for the entire event.
