## Responsibilities of Old Town School of Folk Music (OTSFM) and Limitation of Liability

1. OTSFM assumes the role of broker in referring Leader to Purchaser.
2. OTSFM will collect deposit from Purchaser as specified above.
3. OTSFM will provide copies of signed contract to Purchaser and Leader.
4. Purchaser, Leader and OTSFM agree that:
  - a. OTSFM is not an agent for either Purchaser or Leader.
  - b. OTSFM will not be liable for the default of Purchaser, or non-performance of Leader.
    - b.1. If Leader cannot fulfill this contract, a substitute amenable to all will be sent or a full refund given.
  - c. OTSFM has no responsibilities under this contract other than those listed in items 1,2,3,4,a,b and b1 above.
  - d. Leader assumes full responsibility for payment of any and all compensation and dues to him/herself and sideplayers.
  - e. Purchaser and Leader agree to indemnify and hold harmless OTSFM from any and all liability, loss or damage OTSFM may suffer as a result of claims, demands and costs of judgements against OTSFM arising from the musical services provided under this contract, including, but not limited to, the musical services rendered, transportation to and from engagement location, and any set up or break down of equipment involved with the musical services.
5. Artist will set up equipment immediately prior to the designated starting time. Earlier set up time is subject to the availability of the musicians and a possible additional charge. Any delay in starting time caused by Purchaser or venue shall not affect the ending time stated in this contract for their musicians.

This contract cannot be canceled except with the mutual written consent of all the parties. In witness whereof, the parties to this contract have signed their names on the date appearing under their respective names. Artist will take one 10-15 minute break per hour played. **Cancellations must be made no less than 14 days prior to the event in order for the balance to be refunded. There are no refunds on the deposit.**
