1. Briefly describe the project. What was done, when and where did project activities take place, and who were the beneficiaries?

The Covid 19 pandemic was the principal driver of circumstances that more than doubled the cost of buying and transporting septic tanks for our ongoing Sanitation Initiative for Corazon Communities in Baja Norte, Mexico.

A Matching District Grant from 2022-23 provided us with molds (tools)

The contractor who was originally intended to produce these tanks in Mexico was unable to for bureaucratic reasons.

Training was completed to allow tanks to be completed by others in Mexico thereby achieving the original goals.

2. How many Rotarians participated in the project?

Two so far have participated in the training and logistics.

Many more will participate in the installations of these septic systems and some of the houses that will be connected to them.

3. What did they do? Please give at least two examples.

Provided the training required to utilize the molds to produce high quality septic tanks that will bring indoor plumbing and sanitation to many very poor families in rural Mexico that otherwise only have use of outhouses and cesspools.

Another Rotarian participated in the training to be educated in the evaluation of tanks produced in Mexico.

4. How many non-Rotarians benefited from this project?

Entire communities will benefit from converting open sewer sources to sanitary best practices.

5. What are the expected long-term community impacts of the project?

Improved health and quality of life for all.

A fundamental and significant improvement in the standard of living for the entire (often multi-generational) family.

6. If a cooperating organization was involved, what was its role?

Corazon vets the receiving families and ensures that they trained in proper use and maintenance.

They are learning to install systems without supervision, moving towards true sustainability for this Rotary Project.
