## **Project Overview**

# Tell us a little about your project. What are the main objectives of the project, and who will benefit from it?

What is Happening?

There is only one crossing between the Southern African country of Zambia and neighboring Botswana, which is in the town of Kazungula. The Zambezi River flows between the two countries, and all vehicles must be carried over on a pontoon. Commercial trucks wait in a queue for up to 10 days, during which time the drivers play cards, listen to music, and way too often, entice vulnerable young girls and women to "entertain" them. This is much easier than it should be in an extremely impoverished town with a history of sexual abuse and child marriage. With no alternative sources of income, many girls and young women become victims.

#### What Could Possibly Be Done to Help?

There is a ray of hope. Prominent civic leaders in Livingstone, Zambia—a nearby tourist destination—decided to take action. They identified 3 areas where trained young women can find employment—tailoring, computer work, and food preparation. They formed an NGO, and opened The Grace Centre for counseling and training. They have ambitious goals, but so far, only the tailoring program has funds, and they have enrolled 30 young girls and women. There are funds to build the food preparation school and restaurant, a first for Kazungula! However, funds are needed for the equipment and training. Some computers have been acquired to date, but funds are needed for training. Trained graduates will be highly employable at the local customs offices, as well as tourist hotels and lodges around Livingstone.

This grant will provide the following:

- 1. Funds to operate the restaurant and catering school and the computer training program for 3 years. After 3 years, it's expected that the Grace Centre will be generating income through the restaurant and take-out food service, and the production of tailored goods.
- 2. Funds for secondary education for 50 girls enrolled in the Grace Centre who have the potential to finish secondary school, but do not have the resources. Currently in Kazungula, only 10% of girls can finish secondary school. This diploma will be gained simultaneously while they are being trained at the Grace Centre. For those girls who want future employment in computer work and restaurant management, secondary school education is usually required.
- 3. Funds to operate an Internet café and shop. This will also be the first of its kind in Kazungula. The Grace Centre plans for the Internet café to develop an online placement program to assist the girls in employment opportunities in Livingstone and elsewhere.
- 4. Funds for a toilet and shower block that will be needed for the restaurant and catering school. This will include a septic tank.
- 5. Funds for a vegetable garden and chicken house. These funds will also be used to build a water tank and drip irrigation system.

The Rotary Club of Livingstone has formed a committee to manage all aspects of this project. The committee will consist of:

- 1. The Project Leader (PL) is responsible for the overall roll out and execution of the project. The PL will coordinate with other committee members, liaison with personnel of the Grace Centre and be the lead person in interacting with the members of the International Rotary Club.
- 2. The Project Administrator is responsible for all project documentation and record keeping.
- 3. The Project Manager (PM) is responsible for supervising the purchase and delivery of all restaurant, catering, computer and Internet materials. The PM will make bi-monthly visits to the Grace Centre to observe that all materials/equipment are well-maintained and that any replacement parts be submitted for review.
- 4. The Project Financial Officer (PFO) is responsible that the all funds are distributed and managed as agreed to. The PFO will ensure that all funds are managed in a manner which adhered to the fiduciary obligations of TRF. The PFO will review all invoices and be responsible for payments to various vendors.

#### Describe the role that international Rotarians will have in this project.

The Rotary Club of Ventura will share in the fiduciary responsibility for all aspects of funding. A Rotarian will

be selected as the chair of the Global Grant Project who will remain in that position for the duration of the project and its funding. Additionally, this same chair will make yearly visits to the Grace Centre to confirm that the funding is managed appropriately, to assist in any marketing promotion that will be needed and to maintain that the Livingstone Rotary Club has continued access to all financial documents as they relate to the global grant and the Grace Centre.

The global grant committee of the Rotary Club of Ventura will actively promote this project, both thru district 5240 as well as Rotary International. Additionally, the chair will actively work with local Kazungula and Livingstone officials as well as government agencies to promote this project and highlight the role that Rotary International has and continues to play in raising the economic sustainability of citizens in Zambia and throughout the African continent.

# Sustainability

### **Humanitarian Projects**

#### Project planning

#### Describe the community needs that your project will address.

Kazungula has over 90% unemployment with a per capita income of less than fifty cents per day. Less than 15% of all children reach secondary school, and the rate for girls is usually even lower than that. Attending secondary school requires the payment of school fees, which most families cannot afford. With no education

and no chance of employment, many girls in their teens marry young and/or fall prey to sexual abuse and prostitution.

There are no vocational training programs in Kazungula or the surrounding villages, and traveling to other towns, such as Livingstone, is not a possibility for all these girls.

#### How did your project team identify these needs?

A comprehensive needs assessment was undertaken in 2016-2017 by the Grace Centre founders (members of the Lushomo Trust), Rotarians from the Livingstone Club, and a Rotarian from the Rotary Club of Ventura. In addition, an in-depth series on Kazungula was published in the Zambian Times in 2016.

The assessment involved meetings with members of the Department of Social Welfare, the Kazungula Victims Support Unit, the District Commissioner's Office, the District Education Board for Kazungula province, and the Kazungula Chamber of Commerce. In addition, local religious and tribal leaders were consulted.

#### How were members of the benefiting community involved in finding solutions?

The Grace Centre held several town hall meetings with civic and tribal leaders as well as the members of the general community. Additionally, one-on-one interviews were held with members of the office of the District Commissioner, the Department of Social Welfare, the Victims Support Unit, the Gender-Based Violence Center in Livingstone and Kazungula, and the District Education Board for Kazungula province. Also interviewed were local tribal and religious leaders and young girls and their families.

#### How were community members involved in planning the project?

Community members were involved in all aspects of the initial planning process. All of the previously mentioned groups were asked what type of projects could most benefit the young girls and women of this community. The areas of training that will be focused on in the Grace Centre are ones by the community members as the ones with most promise for this community.

- 1. Government officials expressed overwhelming support for funds to assist young girls to gain a secondary diploma, and therefore have an opportunity to be further trained and/or employed.
- 2. The District Education Board stressed that without funding, no advancement could be made in raising the rates of secondary education.
- 3. Members of the Chamber of Commerce and proprietors from local tourist establishments expressed that there is a demand for a restaurant facility in Kazungula (none exist at this time), and for people trained in food service.
- 4. Families from the community spoke of the need for their girls to be educated and to gain an opportunity to learn a skill. Many community members voiced their support for the tailoring program already in existence, and were enthusiastic about a center for computer and restaurant training.

# Will you work in coordination with any related initiatives in the community? Yes

#### Briefly describe the other initiatives and how they relate to this project.

Currently the Department of Social Welfare, the Victim Support Unit and the Gender-based Violence Center are conducting sensitization programs in Kazungula and surrounding villages. These programs encourage young girls and their family members to report sexual abuse and/or coercion into early marriages. These organizations are enthusiastic about the potential expansion of the Grace Centre, and will work in conjunction with the Centre to inform parents and young girls of the new opportunities.

#### Please describe the training, community outreach, or educational programs this project will include.

The Grace Centre project has wide-ranging community goals:

- 1. The computer skills training program, in conjunction with the completion of secondary school diploma, will allow the girls to get jobs in a number of institutions in Kazungula and also in Livingstone, a thriving tourist destination.
- 2. The catering and restaurant management program will train the girls to become cooks at the many tourist establishments in and around Livingstone. Also, for those individuals who also receive the secondary diploma, restaurant management can be a possibility.
- 3. The Internet café, the first of its kind in Kazungula, will attract local community members to access the

Internet and it will become a gathering center for young girls and boys to connect with the world and also to explore employment opportunities outside of Kazungula.

#### How were these needs identified?

The Department of Social Welfare and the District Education Board clearly identified a special need in Kazungula due to the border crossing delays, and the subsequent opportunity for sexual exploitation of young girls. Due to extreme poverty, education and training is not an option for most families in this community. In addition, boys are the priority. Consequently, many families choose to allow their young girls to either be married in their early teens, or to be sexually exploited for very small amounts of money.

The only permanent answer which was identified by all community leaders was an opportunity for training, and for some of the girls with potential, the funds to complete their secondary education.

# What incentives (for example, monetary compensation, awards, certification, or publicity), will you use, if any, to encourage community members to participate in the project?

The incentive is already there for the community leaders. They have undertaken the Sensitization Program, with a main goal of reducing early marriage and sexual abuse, and are excited about any type of educational and training initiatives that can help further these goals.

The incentive for young girls is obvious, which is hope for their future. In regards to their families, community leaders believe that they will also see the potential of having their girls trained and employed, and therefore able to continue ongoing support for the family.

The Grace Centre also plans to develop an online placement center which will be publicized and promoted by the local Chamber of Commerce and community groups and leaders.

The Grace Centre is part of the umbrella organization, Lushomo Trust, which is composed of civic and religious members of the community. They are invested in the successful outcome of this project, and will oversee the continuation of the project.

#### Explain the process you used to select vendors.

Most of the the materials will be purchased locally. Because the Grace Centre/Lushomo Trust board is composed of many board members from the Lubasi Orphanage Home in Livingstone, relationships have already been established with local vendors. The local vendors have agreed to offer the same discounts to the Grace Centre as they give to the Lubasi Home. And these local vendors take pride in supporting the Lubasi Home and they are very enthusiastic to support the endeavors of the Grace Centre.

Some of the kitchen equipment will need to be purchased in South Africa because the prices for these goods are prohibitively higher in Zambia. Mr. Murrin has solid working relationships with South African firms that specialize in kitchen equipment.

# Did you use competitive bidding to select vendors? Yes

The building will be maintained by personnel at the Grace Centre and supervised by Alvin Sindowe, who has a construction and equipment firm in Kazungula and who constructed the existing buildings at the Grace Centre. He has confirmed that he and his staff will maintain the center. Mr. Sindowe's staff will maintain all kitchen, computer and Internet equipment.

Andrew Murrin, the current President of the Rotary Club of Livingstone, and the owner of a very successful lodge in Livingstone (the Green Tree Lodge), will also train the restaurant and catering students and staff on maintaining the kitchen equipment and supplies.

Antony Ranjan, the founder of Grace Centre, has an accounting business in Livingstone that employs a computer repair specialist. Mr. Ranjan will have this same repair specialist maintain the computers and the Internet modems at the Grace Centre.

# Describe how community members will maintain the equipment after grant-funded activities conclude. Will replacement parts be available?

The Grace Centre will become self-sustaining within the 3 years of the grant. To obtain this goal, the employees and students will be taught basic skills for maintaining the building and equipment. In addition, Alvin Sindowe and Antony Ranjan have made a commitment to volunteer their services as well as those of their staffs.

The kitchen equipment from South Africa will be similar to the equipment that is presently used in Zambia. All other equipment will be from Zambia and therefore culturally appropriate.

# Have you found a local funding source to sustain project outcomes for the long term? Yes

#### Please describe this funding source.

Within the three-year funding plan, the Grace Centre is expected to become self-sustaining. In regards to additional local funding, as needed, the local community leaders who will direct this project have been able to obtain large local donors, including the Sun Hotel Group, for their past efforts. They have all expressed their confidence that once the Grace Centre is fully-operational, they will gain their support for this project.

#### Will any part of the project generate income for ongoing project funding? If yes, please explain.

Yes. The expectation is that both the restaurant/catering and the tailoring operations will be revenue producers. These revenues will be used to train more girls, to offer funds for more girls to obtain their secondary diploma, and to expand the job placement operation so that more girls are employed in Kazungula, Livingstone and elsewhere.

A conflict of interest is defined as a situation in which a Rotarian, in relationship to an outside organization, is in a position to influence the spending of TRF grant funds, or influence decisions in ways that could lead directly or indirectly to financial gain for the Rotarian, a business colleague, or his or her family, or give improper advantage to others to the detriment of TRF.
