1. The underserved and uninsured amputees in the community have no access for prosthesis in their lifetime leading to economic stagnation.
2. There is a significant prevalence of amputees in the community
3. There is a lack of expertise, formal training for amputee care and rehabilitation.

1. There is a general lack of access for prosthesis and amputee care for the general population.
2. There is little evidence of development of high tech smart prosthesis in country.
3. There is a lack of resources to develop High tech prosthesis

1. There are signs of strong bonding and development of peer support among the varied groups.
2. The hospital, leadership, and the local government is vested in developing a sustainable model at Hospital Nacional Danile Alcides Carrion .
3. Dr Mary Quervalu , Director of rehabilitation at the hospital has dedicated all her life to serve the underserved and uninsured in her community and is a great leader in her community. She has residents , health care staff , rehab therapists who are readily available to educate and train.

Considering the needs and assets you listed, explain how you determined the project's primary goal.

The community needed access to affordable prosthesis and specialists for amputee care , hence the primary goal was to establish a sustainable amputee care program. We needed to set a sustainable amputee care program and our host country partner Hospital Nacional Alcides Carrion has the resources to accomplish this.

How would your project's activities accomplish this goal?

We have been sending teams since 2006 and started introducing the concepts of amputee care. Setting up a prosthetic lab at the hospital, training and certifying prosthetic specialists and training rehabilitation staff will be the first step in establishing a viable program.

What challenges have prevented the community from accomplishing the project's goals?

Establishing trust with host community.
Lack of support from Hospital administration
Lack of support from local and state government

How is the community addressing these challenges now?

Since 2006 the rehabilitation community has worked diligently with hospital administration and our initial successes even though small has resonated in the local community , city of lima and government agencies.

Establishment of adaptive sports for amputees and the successes in national and international competitions has raised awareness.

Government officials have asked for ambitious plans to establish amputee care program at not only in Lima but in the rest of the country.

Why are the project's activities the best way to meet this community need?

We have a interdisciplinary team of experts in the field who can successfully establish a prosthetic lab , educate and train prosthetists and rehabilitation specialists in amputee care in the community. We have successfully established telehealth link through Hartford Healthcare which opens links for education , training and case consultations.
