

Due to rapid urbanization and human interference many birds are getting affected. Birds hits by vehicles habitat of a large number of species of Birds, such as Peafowl, parakeets. Some of these birds get injured and require treatment. To treat and rehabilitate these birds, our club is proposing to set up a fully equipped bird hospital in Coimbatore, which will be one of its kind in the whole of South India.


