Project Overview

Tell us a little about your project. What are the main objectives of the project, and who will benefit from it?

In India there is high incidence of the Burns injuries. Most of these injuries are household injuries, due to 1. The methods of cooking with wood or kerosene stove

- 2. They cook on the floor
- 3. They use using boiled water on stove for bath.

After the treatment of burns there are many secondary deformities of the face and extremities leading to post burns contractures and scarring. They do not have any financial support for the treatment of the secondary deformities. The government resources are either meagre or misdirected leading to permanent disabilities for these burn victims.

If you have the bird's eye view on these burn victims, they don't remain the part of the mainstream society. They remain in seclusion due to the social ridicule. Sometimes they are solely dependent on other family members for their own activities of daily living. The children suffering from the hand deformities can't eat, write or play with their hands. It leads to inferiority complexes, absenteeism form the schools and they lag behind studies, remain uneducated. In case of adults, they loose their jobs, earning capacity. Very often the victim is the sole bread earning member of the family leading to loss of resources of one generation of that family. The young women with ugly scars or the functional disabilities are often abandoned by their husbands and find difficult to get any support.

Considering the plight if these people, it will be prudent to help them correct their deformities by surgeries and rehabilitate them to the mainstream society.

This project "Hope after fire" is directed towards surgical correction of the secondary deformities of the upper limb, lower limb and face, in the hospital set up on ongoing basis.

The project will address to correct the burn deformities and rehabilitate these patients in term of scolls or the work place.

How did your project team identify these needs?

There is flow of patients approaching Vedant hospital for surgical treatment of the burn deformities. These patients need funding and medical expertise for the correction of the deformities and rehabilitate them.

How were members of the benefiting community involved in finding solutions?

The non-affordable patients being treated at Vedant hospital many a times suggests that the surgeries should be available free of cost to the patients. Vedant hospital already running the skin-bank project which involves outreach program with the help of Rotary. This makes it easy for the outreach program for identification and

deformities and rehabilitate them.

How were community members involved in planning the project?

The local community leaders like Nagar sevaks, Sarpanchas, Talathis, School headmasters, teachers, already know many people suffering from the deformities. By involvement of these people it is easy to reach the target population for the project.

The training of the Medical social workers, Asha workers etc will be done at Vedant Hospital. Hospital has the facility for the training, a seminar hall of 50 sitting capacity.

How were these needs identified?

Dr Rajendra Nehete, senior Plastic Surgeon at Vedant hospital is working since last 22 years in the field. He knows the ground reality of the situation of the victims of the burns which suffer from the deformities and disabilities. There are lot of enquiries regarding the subsidized or free treatment of these deformities at his hospital.

These patients will be operated at Vedant Hospital at free of cost to the patient. The hospital is ready to provide the medical expertise of Surgeon and Anesthetist, free of cost. This subsidizes the cost by almost 30 to 35 percent.
