1. Briefly describe the project. What was done, when and where did project activities take place, and who were the beneficiaries?

On December 19, 2017, in cooperation with the Irvine 2011 Marine Committee, the Irvine Rotary Club provided gifts and other supplies for the Annual Holiday Party for 500 Marines and their families at Camp Pendleton Marine Corps Base. A team of Rotary volunteers transformed an empty hanger into a winter wonderland for the occasion.

Additionally, the Club provided 27 Welcome Home Baby baskets and other baby supplies for Marine families.

2. How many Rotarians participated in the project?

- 20 Rotarians volunteered for activities connected to the Marine Holiday Party
- 11 Rotarians volunteered for activities associated with baby shower gift baskets for Marine families

3. What did they do? Please give at least two examples.

- Rotarians individually donated cash and gift cards to the Marine Holiday Party
- Rotarians shopped for gifts and gift cards for the project
- Rotarians went to Camp Pendleton to set up for the Marine Holiday Party
- Rotarians shopped, assembled and wrapped 27 baby shower gift baskets for Marine families

4. How many non-Rotarians benefited from this project?

Over 500 Marines and their families benefited from this project.

5. What are the expected long-term community impacts of the project?

The project's impact on the community long term are immeasurable. With Irvine's close proximity to Camp Pendleton, this Project furthers the Club's ongoing support of Marines and their families.

6. If a cooperating organization was involved, what was its role?

The City of Irvine's 2-11 Committee was the primary liaison with Camp Pendleton responsible for scheduling the Annual Marine Holiday Party. The 2-11 Committee secured on-base passes for all the Rotary volunteers. They supplied the shopping lists for both the Holiday Party and Baby Shower Baskets.
