#### P-290; Jungle Medical Clinic II Final Report

### **Primary Objectives:**

The Project Objectives of P-290 - Jungle Medical Clinic II at Puerto El Flor, Usulután, El Salvador are as follows:

- 1. Monthly educational training classes on issues related to the physical and mental health, environmental sanitation and prevention of violence to women, groups that are at risk such as pregnant women and mothers of malnourished children and also teach adults and young people in general.
- 2. Demonstrative trainings on healthy cooking recipes based on soy food and promotion of the cultivation of vegetables.
- 3. House calls by nurses and/or nurse practitioners once in two months to each of the participating families to strengthen the educational content provided in the training classes on one on one basis and also to verify the conditions of sanitation within each households.
- 4. Environmental sanitation. These actions are being done by participating families, under the leadership of the community health promoter and the Support Committee and in coordination with the Community Health Clinic

#### **Accomplishments:**

With funding from Rotary International, District 5340 and Del Mar Solana Beach Rotary Club, \$8000 district grant was received in Nov 2013 and the following were accomplished.

- 1. A Medical Clinic was established with health care services provided to 174 families residing at Puerto Flor. The necessary medical equipment, supplies, consumables and drugs etc., were provided. The beneficiaries are the residents of the Jungle Rural Village of Puerto Flor.
- Educational and hands-on training classes were regularly conducted to teach families the basic practice of medical health, sanitation, providing adequate and proper nourishment for children, prevention of violence to women, environmental sanitation etc.
- 3. Hands-on training and teaching basics to improve rural families health and sanitation were provided by a regular house-call nurse visiting houses monthly.
- 4. As a direct result of this project, families showed interest in educating their children. 50 school going children and adolescents at with some learning disabilities were enrolled and teachers recruited to train these students to do simple tasks such as better use of their time, doing homework, maintaining a decent grades in class rooms. This will lead to better education, less drop-outs and better overall academic performance.
- 5. The OEF, local NGO encouraged by this project has since coordinated efforts with the German Embassy to help provide the needed infrastructure for an educational center in the city of Usulután, ensuring a better environment for all students, contributing to their education quality.

The above established medical clinic created under this District Grant P-290 is currently maintained by OEF, a local non-profit NGO and planning to run the clinic at their own expenses as a continuous sustainable project.
