Project Description: Rent assistance for people affected by Covid-19 issues in

Larimer County, Colorado, USA

- 2. Briefly describe the project. What was done and where did the project activities take place? Explain how the beneficiaries and other community members were involved?

Funds were given to Neighbor to Neighbor in Larimer County. N2N works to reduce homelessness and home displacement in northern Colorado. The Breakfast club contributed \$5,000 and District 5440 contributed \$4,000. The total of \$9,000 equated to 12 months of Emergency Rental Assistance at a cost of \$750 per month. The beneficiaries were vetted by N2N and the monthly \$750 was paid directly to the respective landlord. Staff at N2N worked with the beneficiaries to help them retain long-term housing. Annually, N2N secures stable housing for over 5,000 local individuals by preventing homelessness and displacement, providing budget education, youth programs, homeownership education, and by operating affordable apartments for families and individuals. Brooke Cunningham, Philanthropy Manager at N2N, gave a presentation to the Rotary Club of Fort Collins – Breakfast (approx. 60 members) describing N2N's mission and how our funds were spent. An article describing this District Grant was submitted to the District Newsletter (for publication in December 2020) and to the Fort Collins Coloradoan.

- 3. How many Rotarians participated in this project? Approx. 60 Rotarians attended Brooke Cunningham's presentation and one Rotarian managed the District Grant. Indirectly, the 84 active members of the club were involved.
- 4. What did they do? Please give at least two examples. First, one Rotarian applied for and wrote the District Grant request, arranged for Ms. Cunningham to speak, saw that the checks were sent to N2N, acquired the receipts, wrote an article for the District Newsletter and the Fort Collins Coloradoan newspaper, and submitted the final report. The club's Community Service Committee and the Club's Board of Directors approved the District Grant application. Second, about 60 club members attended the Zoom club meeting when Brooke Cunningham described the work of N2N and how the club/district funds would be spent. Members participated in a question/answer session.
- 5. How many non-Rotarians benefited from this project? One individual/family per month.
- 6. Who are the beneficiaries and what is the expected long-term community impact of this project? The beneficiaries were people who needed Emergency Rental Assistance. The long-term community impact is that hopefully the beneficiaries were able to remain in their housing and not become part of the homelessness community.
- 7. If a cooperating organization was involved, what was their role? Staff at N2N vetted the people receiving Emergency Rental Assistance and provided a wide range of assistance to help them remain in their residences. Brooke Cunningham, Philanthropy Manager at N2N, gave a presentation to the Rotary Club of Fort Collins Breakfast (approx. 60 members) describing N2N's mission and how our funds were spent. An article describing this District Grant was submitted to the District Newsletter (for publication in December 2020) and to the Fort Collins Coloradoan.
