Project Title Community Relief for Covid-19

1. Briefly describe the project. What was done, when and where did project activities take place, and who were the beneficiaries? List any changes that might have occurred.

The Rotary Club of Orland Park donated \$800 to Camp Quality to hold a virtual summer camp for children being treated for various forms of cancer; \$1,000 for elementary school children in School District 135. This support was in the form of gift cards that were given to students' families facing financial emergencies. The students were identified by their teachers and confirmed through the district office. The club provided \$350 to Alvernia Manor and \$350 to Providence Services. Both are nursing homes. The funds were used to provide support for front line workers. Finally, the club donated the remaining \$54 to the Orland Township Food Pantry.

- 2. How many Rotarians participated in the project? 12
- 3. What did they do? Please give at least 2 examples.
 - The club has supported Camp Quality for 15 years by preparing and serving dinners for the campers.
 Since the camp couldn't meet in person, Camp Quality planned a virtual camping experience for the children. Funds from this grant provided arts and crafts materials. Two of our members helped to deliver the materials to the campers.
 - Members set up a financial emergency fund for students in School District 135 where we have sponsored an Early Act Club for 10 years. Funds from the grant will be used for students who are identified by teachers as having extraordinary financial needs due to the pandemic.
 - The two nursing homes receiving funds have had ongoing relationships with our club. One, Alvernia Manor, has hosted Christmas events for members in District 6450. The funds sent to these homes support front line workers.
 - The club has been supporting the food community for more than 15 years through donations of food and cash. Members also volunteer to stock food and prepare packages for distribution.
- 4. How many non-Rotarians benefitted from this project? 100+
- 5. What are the expected long-term community impacts of the project?
 - These projects provide financial and human resources to help keep these community institutions strong during the pandemic.

 - We shared information on our website and asked each organization to post our "Rotary Supports Heroes" signs on their properties.
