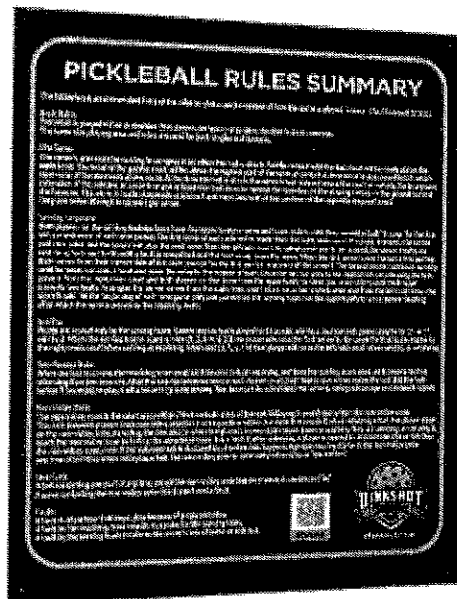

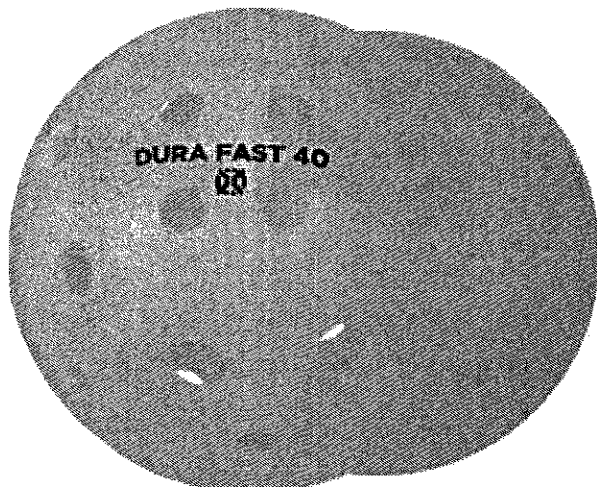

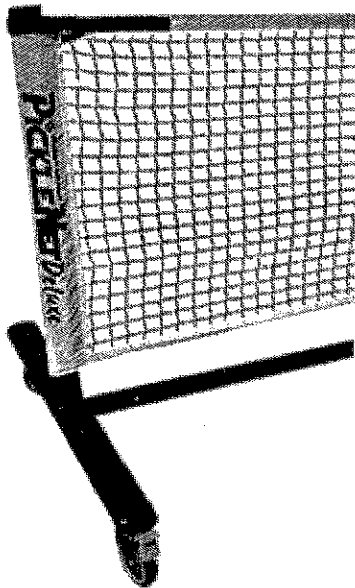

The Palmer and Wasilla Sunrise Rotary clubs would like to refurbish the playing surface of the 3 Palmer tennis courts located on Elmwood and Gulkana Streets in Palmer, Alaska.

The total estimated cost of the project is \$175,000 to \$200,000.00. The project will commence August 1, 2021. The expected completion date is June 30, 2022.

MatSu Tennis Association 501(c)3 is entering into this agreement with Wasilla Sunrise Rotary, Wasilla, AK, and Palmer Rotary Club, Palmer, AK, to work in partnership in refurbishing the Palmer tennis courts.

Each Rotary organization will provide funding to be held in deposit with MatSu Tennis Association to be used for the reconstruction project of the Palmer tennis courts. MatSu Tennis Association will use these funds to pay contractors and construction costs for this project.

MatSu Tennis Association is not required to provide any funds beyond what is raised or transferred by Palmer Rotary and Wasilla Sunrise Rotary Clubs.

If the project is not completed by June 30, 2023, or the funds are not allocated by the projected completion date, all funds will be refunded to the respective contributors, Palmer Rotary and Wasilla Sunrise Rotary organizations.
