In collaboration with the City of Chicago, The Chicago Community Trust and United Way of Metro Chicago launched the Chicago Community COVID-19 Response Fund to unite the funds raised by Chicago's philanthropies, corporations and individuals to be disbursed to nonprofit organizations across the region. The funds will provide increased access to emergency food and basic supplies, rent and mortgage assistance, utility assistance, direct financial assistance for household supplies, and nonprofit safety and operations assistance.

CCRF grants have been distributed to more than 350 nonprofit organizations to support their food, housing, healthcare, financial assistance, and community hub work. Some examples of the impact of a \$500 donation include:

- Meals: providing 200 meals to approximately 20 families
- Direct Cash assistance: helping one family with rent/mortgage, utilities or simply diapers and formula
- Health: purchasing PPE, cleaning and other medical supplies
- Housing: connecting individuals and households to safe shelter

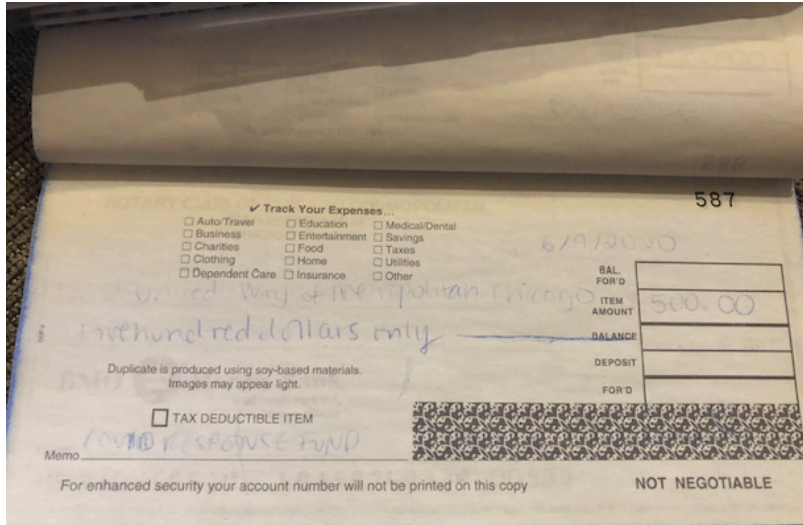

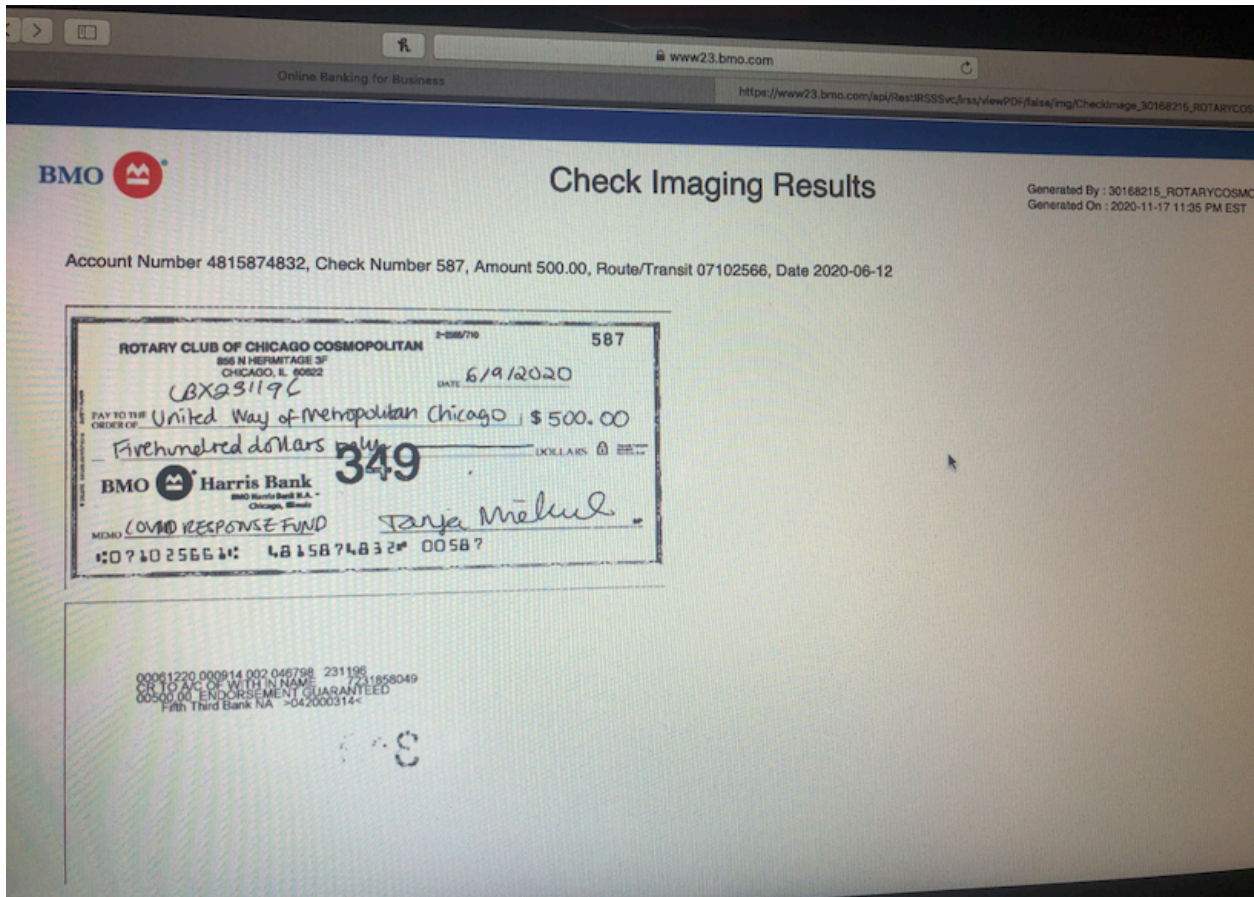
