Refund Policy

Shipping Returns

CONFERENCE & LIVE EVENTS REFUND POLICY

All refund requests must be in writing through the contact form on this website and received 60 days prior to the start date of the conference/event. No refunds will be granted after that. A full refund, less a \$150 administrative fee, will be made within 45 days after the completion of the conference/event.

There are no refunds for no-shows.

Substitutions are allowed. There is a \$50 substitution fee for each substitution.

For cancellations received five (5) or more business days prior to an event, workshop, academy or seminar for which a fee has been paid, a full refund less an administrative processing fee of 10% shall be provided to the registrant.

Participants withdrawing five (5) or more business days prior to a workshop for which a fee has been paid may elect to put their payment on hold for six (6) months from the date of cancellation and choose another workshop of equal value. Replacement workshop must be selected at time of withdrawal. The payment will be credited to the new workshop. If the participant does not register for a new workshop within the six (6) month hold period, no refund will be issued.

No refunds or credits shall be provided for withdrawals made within five (5) business days. Participants will be invoiced the full cost for no-shows.
