1. Briefly describe the project. What was done, when and where did project activities take place, and who were the beneficiaries? Plan: Provide a new book (recommended by the school, per grade) for each student in grades K-3 at Franklin and Hoover elementary schools in Santa Ana.

Actual: due to better pricing (see 6, below) we were very happy to be able to provide a recommended book for EVERY student in these two schools.

Books received were checked against order; sorted by school and grade; had a printed sticker bookplate added to inside cover, and a Rotary 4-way test inserted, then re-packed by school and grade (all this on Feb. 13), then delivered to the two schools (March 10).

2. How many Rotarians participated in the project?

3. What did they do? Please give at least two examples.

Getting student counts by grade; getting recommended book lists by grade; sourcing books (pricing from at least two sources); sorting books by grade and school; affixing a book label to each, and inserting a book mark to each. Participation was limited by Covid (# people inside office suite, maintaining significant distance); delivering to the schools.

- 4. How many non-Rotarians benefited from this project? 760 elementary students.
- 5. What are the expected long-term community impacts of the project?

  Books in the home have a high positive correlation with early childhood literacy. These two schools are among the poorest areas in Santa Ana, and unlikely to have a lot oof books in the home. With Covid pandemic eliminating or limiting library access, books in the home can have an even bigger positive impact.
- 6. If a cooperating organization was involved, what was its role?

The schools said Scholastic would provide the best prices on the books, but when a Barnes & Noble employee was told of the project they provided a much lower price, so that we could give a book to every student in both schools, rather than just K-3 as anticipated.
