



Thank you for your call. I've attached several pictures along with a rough sketch of the octagon dimensions. As I mentioned, the gaga pit is a 20' diameter, so you can do a 24'-26' slab, which will provide adequate space on the exterior of the pit. Please see the baseboards that we talked about for underneath the ADA jambs and rest of the brackets.

When ordering, if you want to reference estimate #14807, that would help anyone on our end to find that.

Let me know if I can provide any additional information.
