We connected with Moos Elementary staff and teachers to identify books they needed for their Pre-K and Kindergarten classes. In total, we ended up ordering 57 books to be used in Moos Elementary classrooms. Books were ordered in December 2020 and dropped off at Moos Elementary on January 7, 2021.

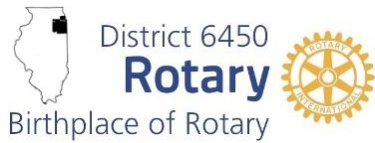
