In October Rotarian Ed Burnett printed off labels with donated supplies. Ed Burnett, Shirley Conger and Nikki Zogg labeled the books with 3 Way test and Canyon County Sunrise Rotary Identification and information. Books were distributed to schools the week of Oct 19 and completed on Oct 26. Note: Because of Covid-19 protocol, the books were delivered to the schools and distributed to students by their teachers.
