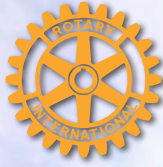

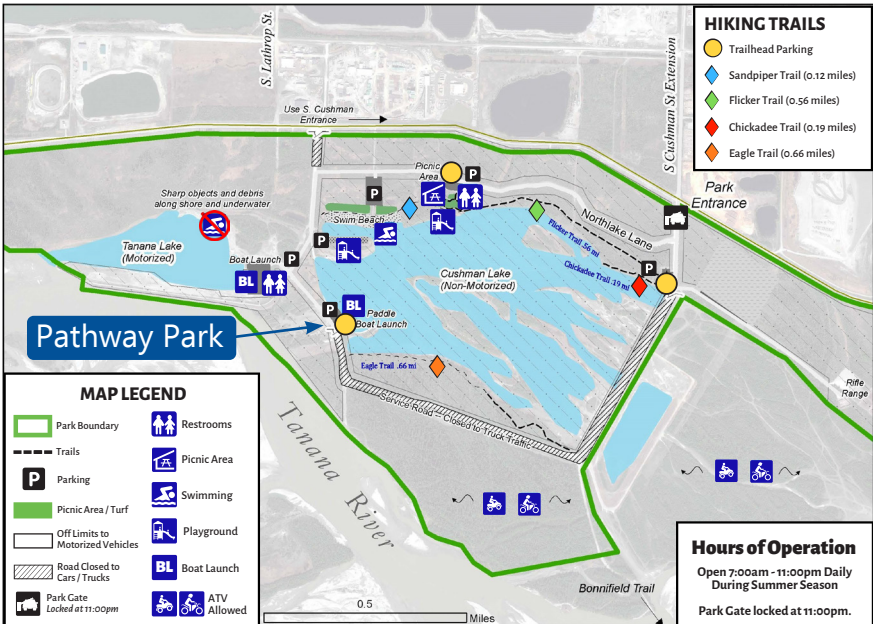

The Tanana Lakes Recreational Area is a project of the Fairbanks North Star Borough. Land once used to dump old car bodies (and some human ones) and to host various kinds of illicit activity, has been transformed into a family-friendly recreational center. The location is adjacent to what was once considered a depressed area of the community. Development is ongoing, and the community has already begun to embrace the site's many opportunities for fun and recreation.

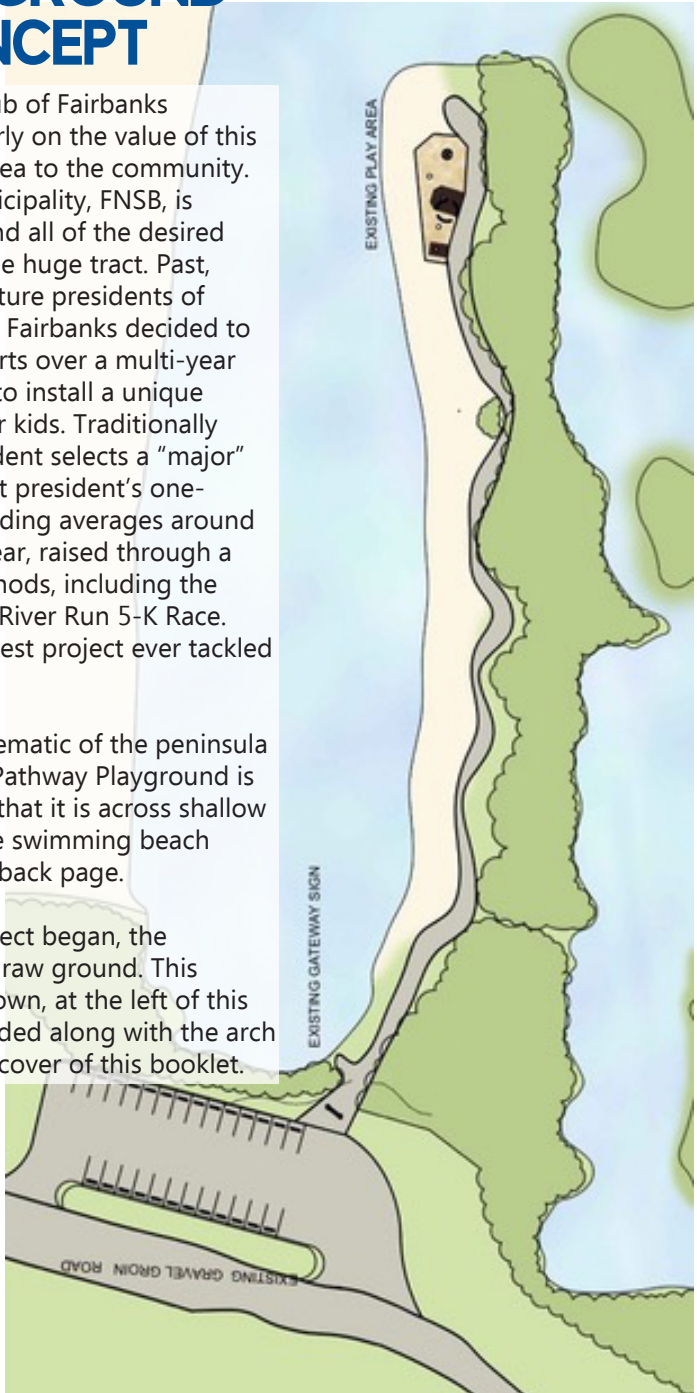


BACKGROUND & CONCEPT

The Rotary Club of Fairbanks recognized early on the value of this recreational area to the community. Our local municipality, FNSB, is not able to fund all of the desired activities on the huge tract. Past, current and future presidents of Rotary Club of Fairbanks decided to pool their efforts over a multi-year span in order to install a unique playground for kids. Traditionally the club president selects a "major" project for that president's one-year term. Funding averages around \$10,000 per year, raised through a variety of methods, including the annual Chena River Run 5-K Race. This is the largest project ever tackled by the Club.

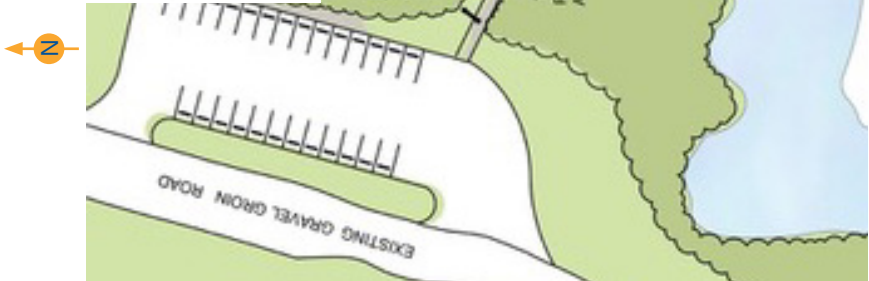
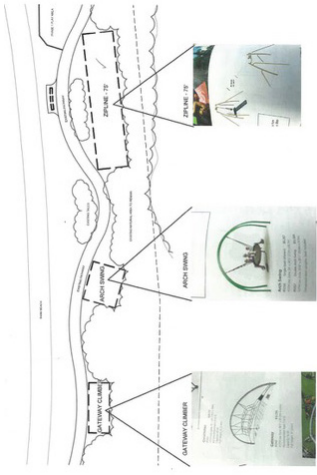
Below is a schematic of the peninsula on which the Pathway Playground is located. Note that it is across shallow water from the swimming beach shown on the back page.

When the project began, the peninsula was raw ground. This parking lot shown, at the left of this image, was added along with the arch shown on the cover of this booklet.

INSTALLED ELEMENTS

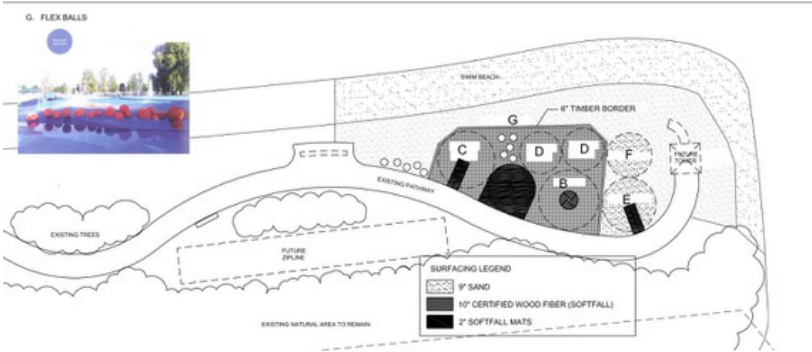
Shown are the current installations. All of the equipment installed and planned is of the best quality with high safety ratings. Installation has been done by professionals.

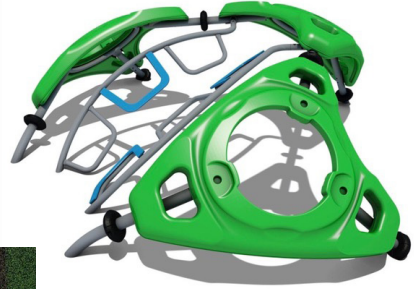

The above extract from the Rotary Club of Fairbanks financial accounts shows expenditures through the purchase of the three units of equipment to be installed in the summer of 2021. This does not include donations such as the services of the architectural firm, Design Alaska.
