The Making Every Student Accountable Program MESA is a after school proram run by the Mesa Police Department in Partnership with the Mesa Unified School District.to assist at-risk yout at Kino Jr. High to take responsibly for there own education. M.E.S.A. Program Class #30: Started with 23 students participating and graduated 14 hardworking students. Students completed the program October-December 2021 (nine weeks). Used gift cards to motivate and incentive students weekly for improving grades and winning workout challenges set by Officer Martinez. Students participated in "Love Your City" service project that was a city-wide day of service to clean their neighborhood park. M.E.S.A. Program Class #31: 17 students currently attending the program March-May 2022 (nine weeks). Are working with CBI to implement life skills lessons, as well as implementing curriculum called Thrive. Thrive addresses the challenges facing teens with a focus on the risk and protective factors that promote positive choices and healthy behaviors.
