Thank you for the response. Our entire budget for this project will be \$5,335.00. We will pick up, so there will be no need for shipping. Our (loose) breakdown is as follows:

- SC: 208 @ \$25.00 = \$5,200.00
- Decorating “kits”: 9 @ \$15.00 = \$135.00
 - I’m not sure how these work now, it would appear they are separated by Fabric Pastels and Stencils; last year they were itemized as Decorating Kits
- **Grand Total = \$5,335.00**

Will this budget work? We will be outright sponsoring/purchasing, as opposed to fundraising. This will be part of a ROTARY District Grant, so there is an application/approval process that we are currently going through, so I am unable to give you an exact timeline (yet) for ordering.
