 3. Briefly describe the grant and list any changes that might have occurred (100 words or less).
Grant funded family passes to the St. Paul City swimming pool and for the classes in the summer recreation program. Swimming pool passes were funded for 36 children from 13 family units. Summer recreation classes were funded for two children from one family. Lack of requests for Summer Recreation Classes yielded \$528 unspent money. The Club Board of Directors suggested contacting the Howard County Medical Center Wellness Center for possible small funding needs to benefit people with fitness needs. The remaining \$528 will be donated to the Wellness Center within the Howard County Medical Center for items to enhance member usage.
 4. Provide a brief (100 words or less) of lessons learned in implementing this grant and how this will improve future grant funded projects:
Lessons learned: 1. Prices for services will go up by the time the grant is implemented. Build in some “inflation” reserves. 2. Getting the word out to the target group can be complicated as low to moderate income people can’t afford newspapers and flyers are frequently lost. 3. Don’t give up on a good idea because it isn’t immediately embraced by the people you want to serve. To quote the Rotary 2023-24 motto: “Give Hope.”
