3. Briefly describe your project (who did what, when and where did project activities take place?)
The Idaho Period Positivity organization visited our club in 2024. Girls in school whose period starts early or can't afford appropriate menstrual pads or tampons can feel stressed and panicked. Unless they can hurriedly borrow from a friend or stranger, they must go to the school nurse for product. Surveys show that 70 percent of Idaho 6th through 12th grade girls had missed significant class time due to insufficient period product access. Idaho education funding does not provide these products. In 2025 our project purchased 4,500 wrapped tampons and 14,580 wrapped maxipads that are distributed in SD25 girls' restrooms and counselor offices, significantly more than proposed in P-5150.
4. In one brief sentence: who were the beneficiaries of the grant activities and how many of them were there? Menstrual-age girls in Pocatello-Chubbuck School District 25. Estimate 2,800 girls within a total of 12,000 students.
5. How many Rotarians participated in the project? 5 active, 20 support. Briefly tell what did. Active members coordinated with SD25, Idaho Period Positivity Coalition to plan menstrual product purchases, arranged delivery to SD25 and coordinated publicity.

Idaho Period Positivity Coalition <https://www.idahoperiodpositivity.com/> provides a strategy to address and promote legislation for providing menstrual supplies in all 6th – 12th grade female and unisex bathrooms in the State of Idaho.
