### **Project Overview**

# Tell us a little about your project. What are the main objectives of the project, and who will benefit from it?

Equipping the Thousand Smiles Ensenada Clinic, Located at AV Mexico 124 (Corner of Av Mexico and 18 de Marzo), Fracc Buenaventura, 22880 Ensenada, B.C., Mexico with additional equipment necessary to improve our treatment of patients. This equipment includes Solar Panels, a new Full Digital Intraoral X Ray, a new High Pressure Vacuum Pump necessary for our Operating Rooms, Audiology testing equipment, Dental and surgical supplies. The X Ray, Vaccum Pump, Audiology Equipment, Dental and Surgical Supplies comply with Mexican health authority norms. Thousand Smiles never uses expired or non approved items. This clinic has be in operation since 1985. It benefits mostly children from about 1 month after birth and occasionally adults from financially challenged families mostly from the Baja California area, focusing on patients with maxillofacial deformities such as cleft lip and palate, but providing full dental care for patients without those deformities. The host Rotarians have done community assessments to find out if the deformities occur at the rate they did when the project started and if there are other projects treating them, that were not active when it started. The recent results of these assessments are that the deformities still occur in approximately 1 out of every 640 births in Mexico and while there are now other programs treating them, it was found that all of them are plastic surgery programs that do cosmetic surgery on the lip beginning at around 8 weeks of age and sometimes soft palate surgery beginning at about 1 year of age. The Thousand Smiles Foundation decided very early on to provide a full complement of necessary services, despite the complexity and commitment this requires. The clinic that has recently been remodeled, has 2 new OR's, a fully equipped Audiology suite, ENT Suite, speech pathology services, surgical screening, digital x-ray, 12 dental chairs with 2 separate rooms for more advanced procedures requiring sedation, instrument sterilization capacity for dental and surgery, and warehouse with a complete inventory of non expired supplies. The clinic is licensed by the Mexican Government and complies with all regulations. Thousand Smiles along with UCLA performs 4 weekend clinics per year. The facility is also used by Baja Comunidad two times per year and Loma Linda University plans on using it about 6 times a year. When the clinic is not being used, we do have one full time and one part time employee on duty at the facility. When the clinic is closed we have a local Orthodontist, a local Maxillofacial Surgeon and a local General Practitioner who perform follow up treatment for the patients. These practitioners are members of the Ensenada Centenaria Rotary Club

#### Describe the community needs that your project will address.

The Mexican community has a population segment that is severely challenged financially. These people many times lack basic non urgent health and dental care that most take for granted. The country also has about 1 in every 640 children born with facial deformities such as cleft lip and palate. These children are often sheltered and many do not even go to school. The government has programs to treat these children but unfortunately

does not offer comprehensive care, including orthodontia and bone grafting, and also does not have the capacity to treat all of the candidates even with simple cosmetic soft tissue repair. The cleft lip and palate deformities require a more complicated journey for the patients and their families. Thousand Smiles occupies a very unique space in this area. The care they provide is comprehensive, and they are committed to long term follow up for each patient that needs help. It begins at less than two months of age these patients are frequently seen into their 20's. Feeding at an early age affects developmental nutrition, chronic ear infections affect hearing and ability to interact and form speech, cosmetic abnormalities impact socialization and selfesteem, and importantly these all occur during the most critical developmental periods for these children. The majority of other surgical outreach efforts focus on a single aspect of care, often only surgical repair. Thousand Smiles decided very early on to provide a full complement of necessary services, despite the complexity and commitment this requires. The clinic that has recently been remodeled, has 2 new OR's, a fully equipped Audiology suite, ENT suite, speech pathology services, surgical screening, digital x-ray, 12 dental chairs with 2 separate rooms for more advanced procedures requiring sedation, instrument sterilization for dental and surgery, and a warehouse with computerized inventory control. The facility is as good or better than what you would find in the United States. It is a fully credentialed facility, meeting the same requirements of the other outpatient hospitals in Mexico. The surgeons are the top in the field. Although teaching does occur, the primary mission is to deliver the best possible outcomes to our patients.

#### How did your project team identify these needs?

Our project team has been working with this foundation for many years. We have had input not only from the Thousand Smiles team, but also from their local partners such as DIF - Ensenada (Desarroyo Integral Familiar), Hospital General de Ensenada and Rotarians from the area.

#### How were members of the benefiting community involved in finding solutions?

The Ensenada Centenaria Rotary advertises prior to clinics to inform potential patients and their families. The project receives patient referrals from local doctors, from the Hospital General de Ensenada, and from DIF - Ensenada.

The project planning sessions are and have been attended by members of the Ensenada Centenario Rotary and The Thousand Smiles Foundation Team

#### How were these needs identified?

The solar system was decide on by the board of Directors. After the organization's donations decreased significantly during the covid Pandemic, the Board decided on trying to decrease the clinics monthly costs. The vacuum system was requested by the surgical team. Presently the operating rooms use the dental vacuum system which has lower pressure that that needed in surgery. The x ray will replace an older unit which is having some frequent issues and is not considered reliable anymore. Unfortunately many of our proceedures are impossible or would be too risky without x rays, so the clinic need a reliable unit. The audiology items were requested by the people on that team at a recent clinic to replace worn out items that are not functional anymore.
