## **Project Overview**

# Tell us a little about your project. What are the main objectives of the project, and who will benefit from it?

South Africa is home to the majority of the world's rhinoceros populations, particularly the White and Black Rhinoceros. Unfortunately, this makes the Waterberg region a prime target for poaching, driven by the high demand for rhino horn in the Asian market, where it is used in traditional medicine.

In the first six months of 2024 alone, 229 rhinos were poached in South Africa. Of these, 191 were killed on state properties, while 38 were taken from privately owned parks, reserves, and farms. This alarming statistic underscores the critical role that privately owned land plays in the protection of these endangered species.

Among these private lands, Welgevonden Game Reserve (37,000 hectares; coordinates 24 16.499°S, 28 03.149°E) and Lapalala Wilderness Nature Reserve (48,000 hectares; coordinates 23.8422°S 28.3663°E) stand out as safe havens for rhinos. These reserves have opted not to dehorn their rhinos, a decision that emphasizes their commitment to preserving the species in its natural state. Both reserves are located within the UNESCO Waterberg Biosphere Reserve and are dedicated to balancing economic, social, and environmental imperatives for the benefit of their members, neighbouring communities, and other key stakeholders.

This project's primary goal is to ensure endangered species' survival through environmental conservation and education. Effective funding of these key actions not only provides protection within the reserves, but also extends the influence and impact of conservation efforts beyond their boundaries.

With many of the larger rhino populations in South Africa and Namibia now dehorned, poachers are likely to shift their focus to smaller, privately-owned properties, which often have limited resources. Welgevonden and Lapalala Wilderness are situated within the Waterberg Intensive Wildlife Zone (W-IWZ), a government initiative by the Department of Forestry, Fisheries, and Environment (DFFE) in partnership with the Peace Parks Foundation (PPF).

Through programs like Welgevonden Environmental Awareness Programme and Lapalala Wilderness School, the project will disseminate critical knowledge about conservation. 2. Engaging Local Stewards:

By involving rangers and local community members, the project will ensure local buy-in and support for conservation efforts.

3. Institutionalization: Seed funding and training certifications will be used to create lasting institutional frameworks for conservation.

4. Financial Sustainability:

The project will seek external support and engage in ongoing fundraising activities through ecotourism, funding applications, and private donations. Conservation gate levies are charged at Lapalala Wilderness for overnight guests and custodians/lodges with property on the reserves

contribute Conservation levies for their sites.

#### How did your project team identify these needs?

All of the relevant organizations have been involved in environmental education or the protection of rhino for numerous years (see below) and are well-established in the area. Welgevonden and Lapalala Wilderness are situated within the Waterberg Intensive Wildlife Zone (W-IWZ), a government initiative by the Department of Forestry, Fisheries, and Environment (DFFE) in partnership with the Peace Parks Foundation (PPF), working together to combat poaching within the area. Rhino poaching figures are reported annually and can be tracked over time. Annual Reports are available to substantiate the project needs.

Lapalala Wilderness School started in 1981

Lapalala Wilderness Nature Reserve was formally declared in 2020, but involved in conservation since the 1980s

Welgevonden Nature Reserve established in 1993

Welgevonden Environmental Awareness Programme was established in 2017

#### How were members of the benefiting community involved in finding solutions?

1. Knowledge-sharing:

Through programs like Welgevonden Environmental Awareness Programme and Lapalala Wilderness School, the project disseminates critical knowledge about conservation and provides a platform for discussion of solutions amongst the youth.

2. Engaging Local Stewards:

Rangers and local community members are key to the success of this project, ensuring local buy-in and support for conservation efforts. Rangers fight for the rhino's safety each day and understand the challenges faced. Local community members understand that these reserves provide opportunities for employment in an area which has high unemployment rates - by being stewards and protect these species and the habitats, they are part of the solution.

#### How were community members involved in planning the project?

A number of meetings have taken place within each of the relevant teams within the reserves (largely the Security Departments) to ensure the needs of the reserves are adequately met.

It aims to expose children to wildlife by bringing them to Welgevonden and other wildlife properties. The program also mentors youth in life skills, conservation training, and education. Funds may be allocated to a bursary scheme for deserving candidates or to facilitate additional visits focused on rhino conservation.	6 months

This Global Grant Agreement (Agreement) is entered into by The Rotary Foundation of Rotary International (TRF) and the grant sponsors (Sponsors). In consideration of receiving this Rotary Foundation Global Grant (Grant) from TRF, the Sponsors agree that:

1. All information contained in this application is, to the best of our knowledge, true and accurate.

2. We have read the Terms and Conditions for Rotary Foundation Global Grants (Terms and Conditions) and will adhere to all policies therein.

3. The Sponsors shall defend, indemnify, and hold harmless Rotary International (RI) and TRF, including their respective directors, trustees, officers, committee members, employees, agents, associate foundations and representatives (collectively Rotary), from and against all claims, including but not limited to claims of subrogation, demands, actions, damages, losses, costs, liabilities, expenses (including reasonable attorney's fees and other legal expenses), awards, judgments, and fines asserted against or recovered from Rotary arising out of any act, conduct, omission, negligence, misconduct, or unlawful act (or act contrary to any applicable governmental order or regulation) resulting directly or indirectly from a Sponsor's and/or participant's involvement in grant-funded activities, including all travel related to the grant.

4. The failure of the parties to comply with the terms of this Agreement due to an act of God, strike, government regulation, war, fire, riot, civil unrest, hurricane, earthquake, or other natural disasters, acts of public enemies, curtailment of transportation facilities, political upheavals, civil disorders, outbreak of infectious disease or illness, acts of terrorism, or any similar cause beyond the control of the parties shall not be deemed a breach of this Agreement. In such an event, the Agreement shall be deemed terminated and the Sponsors shall refund to TRF all unexpended global grant funds within 30 days of termination.

5. TRF's entire responsibility is expressly limited to payment of the total financing amount. TRF does not assume any further responsibility in connection with this grant.

6. TRF reserves the right to cancel the grant and/or this Agreement without notice upon the failure of either or both of the Sponsors to abide by the terms set forth in this Agreement and the Terms and Conditions. Upon cancellation, TRF shall be entitled to a refund from the Sponsors of any global grant funds, including any interest earned, that have not been expended.

7. The laws of the State of Illinois, USA, without reference to its conflicts of laws principles, shall govern all matters arising out of or relating to this Agreement, including, without limitation, its interpretation, construction, performance, and enforcement.

8. Any legal action brought by either party against the other party arising out of or relating to this Agreement must be brought in either, the Circuit Court of Cook County, State of Illinois, USA or the Federal District Court for the Northern District of Illinois, USA. Each party consents to the exclusive jurisdiction of these courts, and their respective appellate courts for the purpose of such actions. Nothing herein prohibits a party that obtains a judgment in either of the designated courts from enforcing the judgment in any other court. Notwithstanding the foregoing, TRF may also bring legal action against Sponsors and/or individuals traveling on grant funds in any court with jurisdiction over them.

9. This Agreement binds and benefits the parties and their respective administrators, legal representatives, and permitted successors and assigns.

10. If any provision of this Agreement is determined to be illegal, invalid or unenforceable, the remaining provisions of this Agreement shall remain in full force and effect.

11. Sponsors may not assign any of their rights under this Agreement except with the prior written consent of TRF. Sponsors may not delegate any performance under this Agreement without the prior written consent of TRF. Any purported assignment of a Sponsor's rights or delegation of performance without TRF's prior written consent is void.

12. TRF may assign some or all of its rights under this Agreement to an associate foundation of

TRF. TRF may delegate any performance under this Agreement to an associate foundation. Any other purported assignment of TRF's rights or delegation of performance without the Sponsors' prior written consent is void.

13. Sponsors will comply with all economic and trade sanctions, including those implemented by the Office of Foreign Assets Control (OFAC) of the United States Department of Treasury, and will ensure that they do not support or promote violence, terrorist activity or related training, or money laundering.

14. This Agreement constitutes the final agreement between the parties. No amendment or waiver of any provision of this Agreement shall be effective unless it is in the form of a writing signed by the parties.
